## CLAIMS CORNER

If your license was due for renewal in July, Wildwood must have a copy of the license with the 2015 sticker attached before we can request funds to pay your claim. Please mail, email or fax a copy to the office. Watch for your continuation notice to arrive in the mail and act on it as soon as possible.

**WEB claimers:** If you are using a smart phone to record your menus, be sure to scroll down to click on milk on the menu. You must click on all components for a creditable meal. You should double check your entries on your computer daily to ensure the information is correct.

**All Providers:** Please remember to tell us when school age children are out of school. This has to be done every month. WEB claimers can mark the "sch out" column in Minute Menu or use a child's calendar to show school is out each day. All others should use the Claim Information Form. Let us know when the first day of school starts.

We will need kindergarten information for children who were born September 1, 2009 through September 30, 2009. Use either kinder form (green) or an updated enrollment form. The school information section must be complete for all school age children and "school holidays" marked with times in care. Also mark the meals they will receive if in care all day.

Please do not give your Program Rep anything to mail for you. You are responsible for sending us your claims, license, enrollment forms, etc. Thank you for documenting your pizza as either home-made or extra meat/cheese on your menus. Sauce does not count as a veg choice by itself.
