The state agency that oversees the Child and Adult Care Food Program is the Colorado Department of Public Health & Environment. There will be a few unannounced visits in which two Nutrition Consultants will conduct a visit on their own. This will be just like when your Field Rep comes to do a visit. For the other visits, Wildwood will be receiving a list of the providers that have been selected to participate. CDPHE will also send a letter to these providers as well. What makes it a little different is that the Nutrition Consultants will be conducting the visits and we will be observing. The Consultants will ask to see, in addition to your sign in/sign out sheets, the report of Wildwood's last visit with you. We are not using the bubble forms any longer, but are sending you an email with the report attached or a hard copy of the visit if you don't have email. This report is also available on Minute Menu Kids Pro. We are very excited with this new process and feel the audit visits will be much smoother and quicker. If you have any questions, please ask your field rep during her next visit.

So the short version is, we are due for an audit next year. You may be the lucky winner of an unannounced visit by two nutrition consultants from CDPHE. It is important that you have your last visit report from your rep. If you have any questions, please ask your Field Rep during her next visit.

Claims Corner

August is the first month that most children go back to school. Try planning activities to prepare children for their first day of school. See how high children can count. Have them say their ABC's. Have the children paint pictures of the first day of school. Have the children help with planning after school snacks.

Correspondence courses that have been mailed into the office are graded and certificates are mailed on the first day of the following month. These courses can also be taken online! Go to <u>www.wildwoodonline.org</u>, at the top select CACFP>Child Care Homes, scroll down to and click Food Program Online Training. This area is password protected, so call your program rep or the office for your password.

Don't forget to send in your kindergarten forms & school calendars. Call or email your claims coordinator to let us know when the first day of school starts. And remember to document all school closures, including partial days for testing on every claim. Providers who claim online should mark the school out column. Call us if you need any help. Although we can't change your paperwork, we are here to answer your questions, so that next time you will be reimbursed for all of the meals & snacks you serve.
