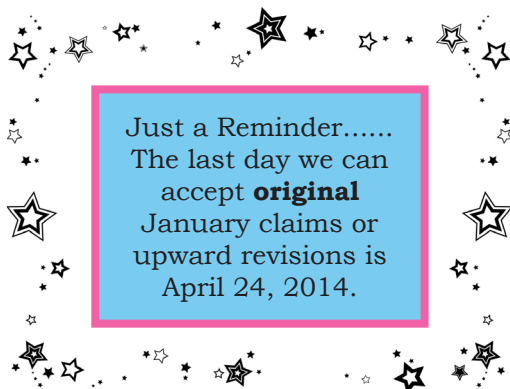

## CLAIMS CORNER

### TIPS FOR ALL:



If your license was due for renewal in March, Wildwood must have a copy of the license with the 2015 sticker attached before we can request funds to pay your claim. Please mail, email or fax a copy to the office. Watch for your continuation notice to arrive in the mail and act on it as soon as possible.

When you are doing new or updated enrollment forms please do not allow parents to write times and/or days vary. They should check mark any day of the week their child may attend your daycare and put the broadest hours in care to cover any situation. "School Holidays" should be marked if a child is kindergarten or school age and time in care should be written on that line. We do not need school information for preschool or Head Start programs.

April is Global Child Nutrition Month. April 1st is April Fool's Day. April 5th is Arbor Day (plant a tree with your daycare children). April 22nd is Earth Day.
