### **KIDKARE – THE NEW WAY TO CLAIM IN MINUTE MENU**

For the last several months we have been encouraging Providers to move from Minute Menu Kids, Kids Pro and Web Kids to KidKare. For those providers that haven't switched yet, we strongly recommend that you make that switch now. You can begin using KidKare at any time during the month and all your data will be available. If you need another copy of your Welcome Letter that gives you your user name and password, please contact the office at – 303-730-0460.

For those that do not switch prior to October 1, 2017, you will automatically be changed over to KidKare. There will be a lot of providers starting KidKare October 1. This will make it difficult to get questions answered or issues resolved.

The scan forms have been modified to meet the new meal pattern. Do to multitude of changes that needed to be made, Evening Snack did not make it onto the new form. It would have to be reported a different way. Because of this, Wildwood has decided to discontinue the use of scan forms. The providers that use scan forms will be able to either claim online or use the manual forms. Please let your Field Rep or the office know which way you would like to claim and we will get you the information that you need prior to October 1<sup>st</sup>. We are available to answer any questions you may have as you determine your new claiming method.

Claims are due in the office by the 5<sup>th</sup> of the month.

*Remember that prior notice must be given to your Program Rep when you are going to be out of your home.*

Caring for Infants: Toddler formula is not creditable for infants.

*If you need help with anything to do with your claims please contact your Claims Coordinator in the office. Contact numbers are listed below.*

Before you know it, school will be starting again soon. All children that are kindergarten age need a kindergarten school form or new enrollment form with their school schedules. If the child is in the age range of being in kindergarten but not attending school this year we still need to know they are not in school. The dates for kinders is 9-1-11 through 9-30-12.
