We want you to receive the most money you can each month. Claims Corner has useful reminders and hints to help you do just that.

- Wyoming providers check your child enrollment forms. Many children have forms that expire in August and September. Get a jump on your renewals to ensure you don't have deductions when forms expire.
- COVID-19 will continue to impact child care programs for months to come. Please let us know if you experience food shortages or program closures.

Any Kindergarten age children in care?

Although school schedules may look different this fall, any child that is five years old on or before September 1st will need a 'Kinder Form' completed regardless of whether they attend kindergarten or not. A Kinder Form for 2020-2021 is available on the Forms & Documents page at
