## Online Training

Wildwood offers several free online training courses. These are not only for the hours required for the food program, but they can be credited towards hours required for licensing. Wildwood will print commonly missed questions on different trainings and give you the correct answers. This is to clear up any misunderstandings and open communication should you have questions.

### **Bullying; Recognize it Early and Stop it:**

Victims of bullying may lose interest in learning, feel helpless or depressed, or engage in self destructive behavior. This is **True**. Being bullied can undermine a child's self confidence and self-esteem.

## CLAIMS CORNER



**We want you to receive the most money possible each month. Here are a few reminders and hints to help with this.**

- If you choose to put your menus in KidKare ahead of the meals being served that is fine. However, you cannot record children's attendance or meals prior to them having that meal.
  - Colorado providers only: new licensing wavier went into effect on December 15th. Now you are allowed to have 2 children under 18 months in your care.
  - Be sure to return phone calls or text messages from your field rep. Until further notice Reps will be doing virtual visits and may need to make an appointment with you. Visits are required per your agreement with Wildwood.
  - Remember to complete a Medical Statement form for any child who has a medical condition that requires a special meal or accommodation.
