Monday, January 21, 2019 is Martin Luther King Jr. Day

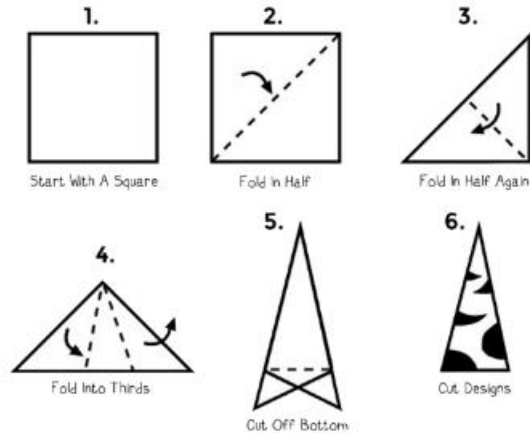

We want you to receive the most money you can each month. Claims Corner has useful reminders and hints to help you do just that.

CORNER

To guarantee on-time payment, your claim is due by the 5th of the month. Unfortunately, we are not able to extend this deadline when there is a holiday or weekend that limits mail delivery during this time. If you struggle to get your claim in by the 5th, we recommend online claiming or priority mail as alternative options.

REMINDER; Home-Made Granola Bars are NOT creditable under the new meal patterns.

Training for Helpers and Substitutes

If you have helpers or substitutes in your program, "Key Staff Training" is required by the state each year. Field Representative will be checking at home visit to ensure all helpers and substitutes are trained.

If they need additional training hours, your helpers can take the same training courses that you do online or on paper through Wildwood.
