

# Make tax time easier for your clients Provide a W-10 form showing the amount paid for childcare

through the year. A blank W-10 form can be found under "Forms and document" for Homes on our website.



Don't let the cold weather give you cabin fever! Try these ideas with your group to keep your blood pumping

- Make a hopscotch on the floor with marking or painter's tape. Show children how to toss a bean bag to each number, then hop to retrieve it and then back to the start.
- Using colorful pompoms and empty wrapping paper tubes, create an indoor mini golf course
- Use couch cushions/pillows to build an obstacle course for children to crawl/climb over, under, around or through
- Bring snow in from outside and let children, scoop, stir or shape it into a mini snowman
- Using a small craft or laundry basket as the hoop, have children take turns tossing pompoms, crumpled paper or bean bags in the basket (Older kids can be farther away than small children)
- Lead children through 3-4 basic yoga poses, talk about focused breathing, and quieting their mind and body (great before nap time)
- When you can get outside with the children, make a snow fort, snowman, or snow angels

We want you to receive the most money you can each month. Claims Corner has useful reminders and hints to help you do just that.

- When school-age children are in care during winter break, please mark them "Out of School" in KidKare or make note on your paper claim of school out dates.
- Milk reminder: Only children between 1-2 years old can have Whole milk on the CACFP. All children over 2 years must be served 1% or Skim (Fat Free) milk.
- Wyoming providers, please send all child enrollment and other forms to the Colorado office listed at the bottom of this newsletter for processing.

\*The last day we can receive original November claims for processing is January 24, 2019.

\*The last day we can receive original December claims for processing is February 21, 2019.
