Once approved, you will be able to print a worksheet for the parents to complete OR the parent can give you the information to enter while you are on the computer. Once the information has been entered, you will print the CEF out, have the parent sign it and mail it to us! We will put out specific directions once everything is final! There is also a possibility, that at some point this year, the parents can go to a website and update their child's CEF and use an electronic signature! What this will mean to you even if you are filing your monthly claim using scan forms or manual forms, your parents will still be able to use this technology.

Continuing our efforts to Go Green, we encourage everyone to use direct deposit. You will receive your money faster! We make the deposit into your account on the first of each month OR we mail your check on the first of the month. The direct deposit will be there instantly and will save you a trip to the bank.

We have mailed out the registration forms for our annual provider conference. This one is going to be fantastic. CLAIMS CORNER

If your license was due for renewal in June, Wildwood must have a copy of the license with the 2015 sticker attached before we can request funds to pay your claim. Please mail, email or fax a copy to the office. Watch for your continuation notice to arrive in the mail and act on it as soon as possible.

If your license changes to a Probationary License you must send us a copy of that license right away. Any change in your license requires a copy sent to our office for your file.

Don't forget to let us know that school age kids are out of school for summer break. Internet providers: please mark "school out" column.

Enrollment forms that expire 7-31-14 or anytime in August: please send an updated enrollment form to the office no later than July 25, 2014.



We will start to gather information on children starting kindergarten in Fall 2014. Internet providers: you can find the kinder form at wildwoodonline.org under news/forms. Kinders are generally born between 9-2008 and 9-2009 for this year. We'll need the kinder information by the time you send in your August claim. Calendars are a useful tool for your file but they don't always have the correct information. We prefer that you send a note on your Claim Information Form each month indicating days when school is closed or school age children are in your care when they are home sick from school. Internet providers: please check mark "school out" column or use child calendars.
