Pretzels & fruit make a creditable snack for all ages.

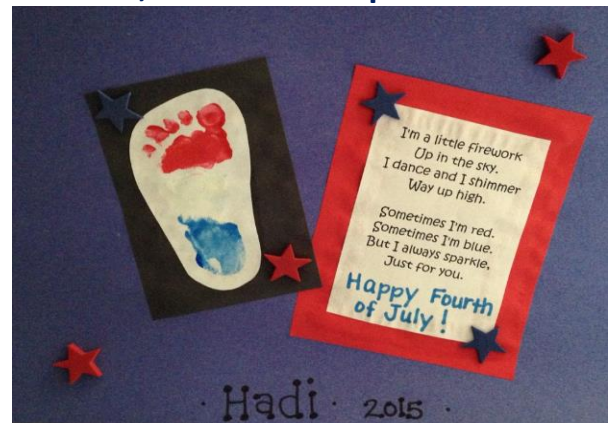


Incomplete Menus?

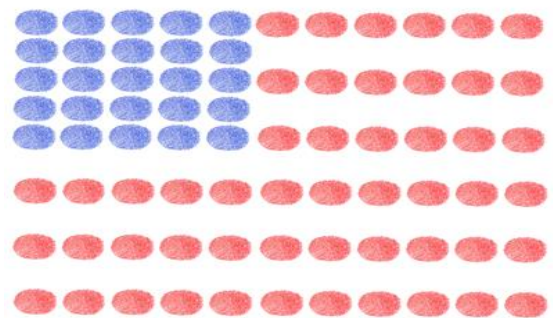

CLAIMS

We want you to receive the most money you can each month. Claims Corner has useful reminders and hints to help you do just that.

- COVID-19 will continue to impact child care programs for months to come. On a temporary basis, Colorado payments will be made earlier than usual. No more waiting until the 1st of the month to receive your reimbursement.
- If you are unable to meet the required meal patterns due to food shortages, please make note of the details on your claim so that we do not make deductions to your reimbursement.

Any Kindergarten age children in care?

Although school schedules may look different this fall, any child that is five years old on or before September 1st must have a 'Kinder Form' on file with Wildwood regardless of whether they attend kindergarten or not. A Kinder Form for 2020-2021 is available on the Forms & Documents page at www.wildwoodonline.org. Give us a call if you'd like a paper form mailed to you for children in your program.

Even though school schedules may look different this fall, Wildwood will need to know which school each child will attend when school resumes. This saves all of us time and can reduce deductions.

***The last day we can receive original May claims for processing is July 24, 2020.**

***The last day we can receive original June claims for processing is August 21, 2020.**
